Our common welfare should come first; personal recovery depends upon AA unity.

"Tradition One basically says that our common welfare comes first--bad news for an egocentric drunk! In my family, that means that the common welfare of the family comes first. My own personal needs, wants, desires, expectations, and dreams all need to be passed through the screen of the common welfare. If the family is going to exist and function as a meaningful unit, then I have to keep one eye on the common good all the time. (If the family self-destructs, my survival is also threatened.)

At work, the common welfare had to come first, too. I couldn't ignore the general directions of the staff and administration, and say to myself, "That's okay for you ordinary folks, but with my creative genius, I can do what I like." No. If the school where I worked was going to exist and fulfill its mission of educating the youth, then all my personal needs, wants, desires, goals, expectations, and dreams needed to be passed through the screen of the common welfare. The common good had to be paramount.

Finally, I need to respect the environment in which I live--the people I live with and work with; the community and country I live in. If the world around me goes for schnitz, I won't have a lot of resources to live on, or with."

- 4. Do I make competitive AA remarks, such as comparing one group with another or contrasting AA in one place with AA in another?
- 5. Do I put down some AA activities as if I were superior for not participating in this or that aspect of AA?
- 6. Am I informed about AA as a whole? Do I support, in every way I can, AA as a whole, or just the parts I understand and approve of?
- 7. Am I as considerate of AA members as I want them to be of me?
- 8. Do I spout platitudes about love while indulging in and secretly justifying behavior that bristles with hostility?
- 9. Do I go to enough AA meetings or read enough AA literature to really keep in touch?
- 10. Do I share with AA all of me, the bad and the good, accepting as well as giving the help of fellowship?"

As an Intergroup Representative, you are responsible for the communication between St. Paul Intergroup and your group. Your job is to attend the Reps' meetings and report back to your group everything that is happening at Intergroup. The time commitment is very small (about an hour every month) but it makes all the difference to St. Paul Intergroup. The Intergroup office cannot function without the efforts of our volunteers.

Taking on a Night Owl commitment means that when still suffering alcoholics call AA for help, they find another alcoholic at the other end of the line. When you or your group sign up to take a shift, you are trained in how to respond to calls and given all of the materials that are needed.
