Made a decision to turn out will and our lives over to the care of God as we understood him.

#### I Wasn't Alone Anymore

I was in and around the Fellowship for three years, sometimes staying sober, sometimes cheating (myself, of course) a little or a lot. I loved A.A. - shook hands with everyone at every door at all meetings I attended, and they were many. I was a sort of A.A. hostess. Unfortunately, I still had a lot of trouble with me.

One member of my group use to say, "If you would just take the Third Step..." He might as well have been talking Dutch! I couldn't understand. Although I had been an honor student at Sunday school, I had gotten far away from anything spiritual.

At one point, I did manage to stay physically sober for six months. Then I lost my job and, at fifty-four was sure I would never get another. Very frightened and depressed, I just couldn't face the future, and my stupid pride wouldn't allow me to ask anyone for help. So I went to the liquor store for my crutch.

In the next three and a half months, I died a hundred times. I still attended a lot of meetings when I could, but didn't tell anyone of my troubles. The other members had learned to leave me alone, because they felt helpless, and I understood how they felt.

One morning, I awoke with a decision to stay in bed all day - that way I couldn't get a drink. I kept that decision and when I got up at six I felt secure, as the liquor store closed at that hour. That night, I was desperately ill; I should have been in the hospital. About seven o'clock, I started to phone everyone I could think of, in and out of AA. But no one could, or would, come to my aid. As a last effort, I phoned a blind man. I had worked and cooked for him several years, and I asked him whether I could take a taxi and come to his apartment. I knew I was going to die, I told him, and I was afraid. He said, "Die and be damned! I don't want you here" (he told me later he his could have cut his tongue out, and thought of calling back. Thank God he didn't!)

I went to bed sure I would never get up again. My thinking had never been clearer. I couldn't really see any way out. By three o'clock in the morning, I still hadn't slept. I was propped-up with pillows, and my heart was pounding almost out of my chest. My limbs started turning numb - first my legs above my knees, then my arms above my elbows.

I thought, "This is it!" I turned to the one source I had been too smart (as I saw it) or too stupid to appeal to earlier. I cried out, "Please, God, don't let me die like this!" My tormented heart and soul were in those few words. Almost instantly, the numbness started going away. I felt a presence in the room. I wasn't alone any more.

God be praised, I have never felt alone since. I have never had another drink and, better still, have never needed one. It was a long way back to health, and it was quite a while before people had confidence in me. But that didn't really matter. I knew I was sober, and somehow I knew that, as long as I lived the way God wanted me to live, I never need feel fear again.

Recently, I was told that I had a malignant tumor. Instead of being afraid or depressed, I thank God for the past sixteen years of borrowed time He had given me. The tumor was removed; I feel fine and am enjoying every minute of every day. There will be many more days, I believe. As long as God has work for me to do, I will remain here.

## The Twelve Concepts: Concept Three

As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision".

"The right A.A. solution for this problem is to be found, however, in the latter part of Tradition Two, which provides for "trusted servants." This really means that we ought to trust our responsible leaders to decide, within the understood framework of their duties, how they will interpret and apply their own authority and responsibility to each particular problem or situation as it arises. This sort of leadership discretion should be the essence of "The Right of Decision," and I am certain that we need not have the slightest fear of granting this indispensable privilege at nearly every level of world service.

There will always be plenty of ultimate authority to correct inefficiency, ineffectiveness, or abuse. If the Conference does not function well, the groups can send in better Delegates. If the Trustees get badly out of line, the Conference can censure them, or even reorganize them. If the Headquarters' services go sour, the Trustees can elect better directors and hire better help. These remedies are ample and direct. But for so long as our world services function reasonably well—and there should always be charity for occasional mistakes— then "trust" must be our watchword, otherwise we shall wind up leaderless.

Our entire A.A. program rests squarely upon the principle of mutual trust. We trust God, we trust A.A., and we trust each other. Therefore we cannot do less than trust our leaders in service. The "Right of Decision" that we offer them is not only the practical means by which they may act and lead effectively, but it is also the symbol of our implicit confidence."

- IV. Treasurer's Report. (Mary Jo) December Contributions (Group and Faithful Fivers) \$5477 52.9% of Income. Contributions for December were above the budgeted amount which makes up for sales which were slightly below budget. December Sales \$4880–47.1% of Income. Group contributions \$3,873–37 of 571 meetings listed on website contributed 571 meetings 160 Groups contributed in 2007 this is up from 155 groups in 2006. Thank You to All. Contributions for 2007 are only about \$2000 less than 2006 even though we had a \$12,000 special contribution in 2006. Group contributions and faith fiver contributions made up this difference. The same is true with our Net Income for 2007. Had it not been for the \$12,000 special contribution in 2006 we would actually have an increase of about \$5,000. Expenses are also up a little in comparison to 2006. We've increased our Yellow Page advertising, one of the ways an alcoholic in need will find us. Our free website hosting period has elapsed and we upgraded our Internet in the office to DSL. We have increased the budget for events with hopes of getting more groups and members involved. We have incurred an Unemployment bill and have included ASL interpretation to events and Rep meetings and will continue to monitor that need.

# <u>The Third Tradition:</u> The only requirement for A.A. membership is a desire to stop drinking.

[The Third Tradition] does state one requirement for membership. Let's read it again, and ask another question: Who determines whether or not newcomers qualify, whether they do want to stop drinking? Obviously, nobody except the newcomers themselves; everybody else simply has to take their word for it. In fact, they don't even have to say it aloud. And that's fortunate for many of us who arrived at A.A. with only a halfhearted desire to stay sober. We are alive because the A.A. road stayed open to us.

The problem faced by this Tradition isn't just past A.A. history. It keeps coming up--for instance, when a group debates whether to exclude alcoholics who have problems other than alcohol or have differing lifestyles. The Tradition mentions no such additional requirements, no demand that prospective members must *not* have a history of drug abuse, a certain lifestyle, or an institutional background. All alcoholics are welcome.
