# STEP NINE: Made amends to such people whenever possible, except when to do so would injure them or others.

## This month we have Bill W's reflections on Step Nine from a period of over twenty years, from 1939 (the Big Book) to 1961 (the A.A. Grapevine).

Yes, there is a long period of reconstruction ahead. We must take the lead. A remorseful mumbling that we are sorry won't fill the bill at all. We ought to sit down with the family and frankly analyze the past as we now see it, being very careful not to criticize them. Their defects may be glaring, but the chances are that our own actions are partly responsible. So we clean house with the family, asking each morning in mediation that our Creator show us the way of patience, tolerance, kindliness and love.

The spiritual life is not a theory. We have to live it. Unless one's family expresses a desire to live upon spiritual principles we think we ought not to urge them. We should not talk incessantly to them about spiritual matters. They will change in time. Our behavior will convince them more than our words. We must remember that ten or twenty years of drunkenness would make a skeptic out of anyone.

The readiness to take the full consequences of our past acts, and to take responsibility for the wellbeing of others at the same time, is the very spirit of Step Nine.

Just how and when we tell the truth—or keep silent—can often reveal the difference between genuine integrity and none at all.

Step Nine emphatically cautions us against misunderstanding the truth when it states: "We made direct amends to such people whenever possible, except when to do so would injure them or others" Because it points up the fact that the truth can be used to injure as well as to heal, this valuable principle certainly has a wide-ranging application to the problem of developing integrity.

Though the variations were many, my main theme was always "How godawful I am!" Just as I often exaggerated my modest attainments by pride, so I exaggerated my defects through guilt. I would race about, confessing all (and a great deal more) to whoever would listen. Believe it or not, I took this widespread exposure of my sins to be great humility on my part, and considered it a great spiritual asset and consolation!

But later on I realized at depth that the great harms I had done others were not truly regretted. These episodes were merely the basis for story-telling and exhibitionism. With this realization came the beginning of a certain amount of humility.

# TRADITION NINE: A.A. as such ought never be organized; but we may create service boards or committees directly responsible to those they serve.

Sometimes the best explanation of a Tradition in the usual, short form may be the "long form" of that Tradition, which can be found at the back of the 12 & 12, or in Appendix I of the Big Book.. While Tradition Eight is the Tradition that most directly applies to St. Paul Intergroup, Tradition Nine also directly addresses Intergroups and Central Offices. — Editor.

Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or Intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our overall public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority form their titles; they do not govern. Universal respect is the key to their usefulness.

## The Twelve Concepts: Concept Nine

Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous.

Vision is, I think, the ability to make good estimates, both for the immediate and for the more distant future. Some might feel this sort of striving to be a sort of heresy because we AAs are constantly telling ourselves, "One day at a time." But that valued maxim really refers to our emotional lives and means only that we are not to repine over the past nor wishfully fantasy or day-dream about our future.

As individuals and as a fellowship, we shall surely suffer if we cast the whole job of planning for tomorrow onto a kind Providence. God has endowed us human beings with considerable capability for foresight and He evidently expects us to use it. Therefore we must needs distinguish between wishful dreaming for a happy tomorrow and the today's use of our powers of thoughtful estimate--estimate of the kind which we trust will bring future progress rather than unforeseen woe.

Vision is therefore the very essence of prudence--a sound virtue if ever there was one. Of course we shall often miscalculate the future in whole or in part. But even so, this will be far better than to refuse to think at all.
