### Came to believe that a Power greater than ourselves could restore us to sanity.

### MY PERSONAL STRUGGLE WITH STEP TWO, BY SUSAN D., OFFICE VOLUNTEER

I was introduced to A.A. at the early age of eighteen, after experiencing blackouts and horrible withdrawals from drinking alcohol. Shortly after it was actually legal for me to consume alcohol, I entered my first treatment. Drinking had caused so much damage in my life that I fully embraced the first step of the A.A. program. There was no need for a counselor to convince me I was powerless over alcohol, and to say my life was unmanageable was putting it mildly, for I could see it was a total disaster.

It was strongly suggested to me upon leaving treatment that I attend A.A. meetings, but even with the acceptance of the First Step, I cringed and rebelled against the Second Step of the program. There were two words in this step I had such a negative opinion on that it deterred me from going to A.A. and getting sober for many years. First, I was appalled at the mere inference I was insane. If I remained dry, surely the men with the white jackets weren't going to haul me away. Second, the God I had learned about as a child in religious schools was all-punishing and sent people to Hell to burn for eternity for their sins. It was difficult to believe this very same God was going to be helpful in restoring my life.

In essence, after looking at Step Two, I made a decision to ignore the counselor's suggestion to attend A.A. I thought it would be best to do it my way, for then I wouldn't be inconvenienced with all this God stuff. Life as a non-drinker would surely bring happiness on its own and make me a winner if I exercised a strong will over my affairs.

Throughout the next twenty-seven years my best intentions and strongest determination failed over and over again, leading to a vicious cycle of being dry, then miserable, and finally getting drunk. I was the "heartbreaking riddle" to all who cared about me.

Despite feeling powerless to fix my drinking problem, I remained too stubborn to entertain the idea of a Higher Power, nor would I accept the idea of insanity pertaining to me. (Although my life could sure be labeled as "insane" by those around me.) Once again I would get back on the horse, holding the reins even more tightly than before, only to fall off again with deeper bruises. Now my attitude toward God was one of belligerence, for how could He be doing this to me?

Even in the depths of despair I wouldn't believe in anything more powerful than my self will, determination and own intellect. I also held on to the belief that by being abstinent from alcohol I would be free from insanity. After all, I was convinced my insanity arose from my behavior while drinking and remained blind to my departures from sanity while I was dry. Without alcohol and without a Higher Power my insanity showed itself quite blatantly as I continued to be selfish, defensive, impatient, miserable and intolerant or as the Big Book states, "restless, irritable and discontent." Living on these principles of self-sufficiency and grandiosity resulted in insanity and ensured I would get drunk yet again.

There were numerous interludes of being on the wagon during which I lived in a state of exaggerated self-concern and felt angry or anxious most of the time. I would jump on the high-speed gerbil wheel of life, frantically working harder and putting in longer hours at my job. I spent much time seeking out more to fill my day, to get relief from my pain-filled emotional jag. All of this doing and self-seeking were tiring and so exhaustion set in, only making my life one horrible chore to endure. Like quicksand, or as the often-referred-to Chinese finger puzzle, the harder I fought to be free, the more I remained stuck in a life of despair. All too often the option of taking a drink seemed a reasonable and rational solution to this frenzy. And so I drank—only to start this pattern over once again.

My last relapse happened nine months ago and it nearly killed me. I needed to be hospitalized for a week to restore my physical health. Perhaps it took a near-death experience to pry open my mind and to have the veil of pride and self-righteousness lifted just enough to allow me to look at the Second Step with a fresh perspective.

It was during my stay at the hospital that I abandoned the scientist in me and picked up the phone to speak to a chaplain. To my surprise he showed up right away and we spent hours in discussion, sharing our thoughts on God. The chaplain was somehow able to dispel a belief I had had since childhood — that a Higher Power is a punishing deity and because of this He wouldn't be of any help in my struggles with daily living.

After leaving the hospital I began to attend A.A. meetings regularly and developed a sincere interest in what the program had to offer. As the fog lifted, I began to notice profound changes occurring in some of the newcomers that could only be described as miracles. In addition, there were others who caught my attention because they seemed to possess something special, and this was a special something I really wanted. Later, I would learn the common thread among the newcomers and those having this special something was their belief in a Power greater than themselves, or more simply, faith.

My next challenge was to face my distaste for the word "insanity." This was easily solved in just one A.A. meeting. When I spoke honestly about the its negative connotation, most of the people in the room smiled. Each person spoke, sharing their ideas on what insanity meant to them. One person said it can be "a lack of soundness of mind," while the next person shared a dictionary definition of "extreme foolishness." With this new information and in reviewing my life, it became impossible to argue with these folks. Yes, I had been insane not only while drinking, but equally so when living life as a dry drunk.

"Came to believe ... " is exactly as it implies: A process. My journey began with a telephone call to a chaplain and continued on when I came to believe the A.A. group I attended was a Power greater than myself. Next, I asked my sponsor for help when old beliefs resurfaced. Over time I observed the miracles occurring in the newcomers before my eyes. I watched as other members calmly dealt with catastrophes, and transcended their pain to live sober and joyous lives. This all defied scientific reasoning and the only way for me to comprehend this was to believe there was something operating that could be explained only by the presence of a Higher Power.

Today, I believe in a Higher Power, whom I call "God," and I have discovered that faith is the absolute crux for us to get well. Finally, after years of loneliness and inner turmoil I have a newly found peace and a connection to the world. By accepting Step Two we begin to heal and by inviting God into our lives we are expelled from the obsession to drink, we move toward sanity and receive the beautiful gift of knowing we are never alone.

### The Twelve Traditions: Tradition Two

For our group purpose there is but one ultimate authority — a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

The Steps are for the individual alcoholic; the Traditions tell us how to run our groups; and the Concepts guide us in how we run A.A. as a whole. But of course, the lessons and principles in the Steps, Traditions and Concepts can be applied to our lives and our fellowship at each level.

The Second Tradition gives us tips on how to understand our Higher Power when we have willingness, but very little experience with faith—when we really don't know what to believe, and how to relate to a Higher Power. Our Higher Power should be a "loving God," merciful and forgiving, as we usually find our fellow A.A. members to be when we do our Fifth Step.

Tradition Two also helps us to find God's will for us when we have little experience with listening for the "still, small voice" that can come after some practice with prayer and meditation, as suggested in the Eleventh Step. Tradition Two tells us that God "may express Himself in our group conscience." When we're confused about a decision or a course of action; when we're angry or upset, we do well to check in with our sponsor, our sober friends, members of our home group before we make a decision or take an action. It's often through talking it over that we begin to see the right course of action; and it's often through this process of spiritual consultation that we gain a feeling of peace when faced with "situations that used to baffle us."

"When, in 1955, the A.A. Groups confirmed the permanent charter for their General Service Conference, they thereby delegated to the Conference complete authority for the active maintenance of our world services and thereby made the Conference—excepting for any change in the Twelve Traditions or in Article 12 of the Conference Charter—the actual voice and the effective conscience for our whole Society."

The General Service Conference meets once each year in April, when the Area Delegates and the staff and trustees of A.A. World Services, the General Service Office and the A.A. Grapevine make decisions on matters affecting A.A. as a whole.

There are two items on which the General Service Conference may NOT act: Changes to the Twelve Traditions, or to Article 12 of the Charter of the General Service Conference. Article 12 is, word for word, the Long Form of the Twelfth Concept. Changes to the Traditions or to Charter Article 12 require the written consent of three quarters of all the A.A. groups.
