STEP FIVE:

Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.

I have heard it said that Step Five is probably one of the hardest steps to take, but also provides one of the greatest opportunities for personal growth.

I was very fortunate to have the opportunity to do my first Fifth Step with someone who hears them on a very regular basis in a treatment center. Coming on the heels of what was probably a far too extensive Fourth Step, I was somewhat worried about how much time this Fifth Step thing was going to take. I had pages and pages of inventory that I believed I needed to get through. My ability to get through all of that stuff in a reasonable amount of time was due in large measure to the focus that was brought to the process. He immediately began to help me see how many of these wrongs were related to a relatively limited number of defects/shortcomings, and that everything leads back in some way to selfishness and self-will (sort of like a demented version of six steps of separation).

My Fifth Step did not involve anything that I could get into any real trouble over. Much of it had to do with admitting to myself and to the outside world that I am not what you see. I was afraid, I worried, I resented people and institutions, my sexual conduct was not always what it should have been. In short, I was admitting that I am not the expensive suit and car that everyone saw . . . the guy who had everything he could need. I was going to be smashing down these walls of protection that I'd worked so hard to construct.

My life, over the almost 15 years of my alcohol abuse, was dominated by lying and deception. Admitting the ways in which I did these things to myself was pretty simple, I was there, I knew what had been done. Admitting them to God was simple as well, he was there too, it wasn't as if I was going to be telling him something he didn't already know. It was that third party to this discussion that had me feeling hesitant. As I said, I had spent years doing exactly the opposite of this . . . what an opportunity to begin changing!

Step Five also presents us with the opportunity to begin to "grow up" spiritually. We are given the chance to become honest about everything we have done, and unload some of that burden that has been with us for years. Once we have the integrity to be honest with God, becoming honest with ourselves and others becomes much easier.

It was through this process, with the assistance of the human being, and with the beginnings of a positive spirituality guiding me, that I learned the exact nature of my wrongs and how to change them and myself with help from God. It was also the real beginning, for me, on the road to peace and serenity.

If you have done your Fourth Step, I encourage you to move, with all reasonable haste to the Fifth. The reward of the experience is worth whatever fear, humility, and mental anguish you must bring yourself to feel. Keep moving forward.

Tradition Five: Each group has but one primary purpose—to carry its message to the alcoholic who still suffers.

Says the old proverb, "Shoemaker, stick to thy last." Trite, yes. But very true for us of A.A. How well we need to heed the principle that it is better to do one thing supremely well than many things badly.

Because it has now become plain enough that only a recovered alcoholic can do much for a sick alcoholic, a tremendous responsibility has descended upon us all, an obligation so great that it amounts to a sacred trust. For to our kind, those who suffer alcoholism, recovery is a matter of life or death. So the society of Alcoholics Anonymous cannot, it dare not ever be diverted from its primary purpose.

And may we reflect with ever deepening conviction, that we shall never be at our best except when we hew only to the primary spiritual aim of A.A.--"That of carrying its message to the alcoholic who still suffers alcoholism."

The Twelve Concepts: Concept Five

Throughout our world service structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered.

Newcomers to A.A.'s General Service Conference are often surprised at the pains taken by the presiding office to make sure the minority has a second opportunity to present its views. Even after extensive debate on an issue, followed by a vote in which a "substantial unanimity" is reached, those opposed are polled individually to see if they wish to speak further to their minority view. In fact, numerous instances can be cited in which this minority view is so compelling the Conference has then reversed itself.

This is A.A.'s "Right of Appeal" in action, and Bill says the same principle should apply to meetings of our area committees, trustee committees and boards. On an issue of grave importance, the minority has the actual duty of presenting its views.

This "Right of Appeal" recognizes that minorities frequently can be right; that even when they are in error they still perform a most valuable service when they compel a thorough-going debate on important issues. The well-heard minority, therefore, is our chief protection against an uninformed, misinformed, hasty or angry majority.
