STEP THREE: Made a decision to turn our will and our lives over to the care of God *as we understood Him*.

Step Three says we have to turn our will and our lives over to the care of God, but that presents a problem for me, because I'm a "show-me" kind of guy: before I believe in something I want to see it with my own two eyes. The reason that's a problem is because being able to manage the invisibility thing is a basic requirement I have for a God.

Luckily, it's very possible to see things indirectly. Like throwing a light switch and noticing the light bulb go on. Didn't see any actual electricity, but did see the light go on, therefore: electricity. You could say, yeah, but it could be anything. And I'd say, You're right, but electricity is the name I give to that "anything," whatever it is.

So I've seen God not because he walked up to me one day and said, Hi, I'm God and I'm an Alcoholic.... And BTW you know he *is* one of us – have you seen the state of the world lately?

I've "seen" God indirectly, by seeing certain effects in the real world, and grouping them under the name of God. You can call it Fred if you like. Or Matilda.

With that out of the way, I had to become convinced to turn over my will and my life, but that presents a problem for me, because I'm a "what's-in-it-for-me" kind of guy as well. I'd like to tell you I'm motivated by unconditional love, and would do things because "it's the right thing to do." Sadly, I find that I'm just the teensiest bit selfish and self-centered.

Luckily, it turns out I can have my cake and eat it too. It turns out that turning it over is all about what's best for yours truly. How do I know? I got tricked/pressured into trying it out by my sponsor, and what do you know – it worked. I applied for my dream job. They didn't call me back the next day to tell me how ecstatic they were I had applied. I obsessed. My sponsor told me to turn it over. I obsessed some more. My sponsor told me to turn it over and apply for another job. "But but but . . ." I obsessed some more – a lot more. Finally, though, out of desperation and a need for sleep, some part of me became willing. I turned it over and moved on. Never got the job, but many other good things came out of the process, things I hadn't even considered might happen.

One of the things I love about the program of Alcoholics Anonymous is that it's NOT based on theory or a set of moral dictates. It's based on what works. So I've learned to turn things over – not because it's the right thing to do, but because experience keeps showing me that it works.

One of the spiritual insights I've gained into my life came a couple of summers ago. I was walking along wrestling with the "God problem" (starts with "Does God exist?" and goes on from there) The full God Committee was in session. All of a sudden I had this image of my entire life stretched out like a ribbon. I could see that for most of my life (colored blue) I was indifferent or agnostic. But for certain periods (colored green), I really lived like I believed in a loving, personal God. What was new was noticing that during the blue periods, my life was neutral to bad, and during the green periods, my life was good. The insight: Hey, God Committee, what else do you need to know??

So I wake up every morning now and pray a Third Step prayer: "God, I offer myself to you – to build with me and to do with me as Thou will. Relieve me of the bondage of self, that I may better do Thy will. Take away my difficulties, that victory over them will bear witness to those I would help of Thy power, Thy love and Thy way of life. May I do Thy will always!" (*Alcoholics Anonymous*, p. 63)

And during the day, when I find myself thinking I know best what's good for me, I recall the words of C. S. Lewis:

There are two kinds of people in the world. People who say to God "Your will be done." And people to whom God says, "Fine. Have it your way."

Tradition Three

The only requirement for A.A. membership is a desire to stop drinking.

"Tradition Three defines the personal liberty of the AA member. It says, in effect, that any alcoholic can be an AA member the moment he says so. Neither can any of us deprive him of that membership, no matter what his behavior. Perhaps no other society has ever staked out such a broad expanse of liberty for the individual as this. Every AA newcomer feels at once that he is wanted and trusted and loved. How well we understand his needs; certainly we have had them ourselves. Seldom has any alcoholic taken unfair advantage of that unlimited charter for freedom. We took this direction for individual freedom years ago. We are glad that we did; there has never been any cause for regret."

Concept Three

As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

"...knowing that theirs is the final authority, the groups are sometimes tempted to instruct their Delegates exactly how to vote upon certain matters in the Conference. Because they hold the ultimate authority, there is no doubt that the A.A. groups have the right to do this. If they insist, they can give directives to their Delegates on any and all A.A. matters.

But good management seldom means the full exercise of a stated set of ultimate rights. For example, were the groups to carry their instruction of Delegates to extremes, then we would be proceeding on the false theory that group opinion in most world service matters would somehow be much superior to Conference opinion. Practically speaking, this could almost never be the case. There would be very few questions indeed that "instructed" Delegates could better settle than a Conference acting on the spot with full facts and debate to guide it. Of course it is understood that complete reporting of Conference actions is always desirable. So is full consultation with Committee Members and Group Representatives. Nevertheless the "instructed" Delegate who cannot act on his own conscience in a final Conference vote is not a "trusted servant" at all; he is just a messenger."
