## STEP TEN - Continued to take personal inventory and when we wrong promptly admitted it.

"Wet, Lather, Rinse, Repeat."

For this alcoholic, Step Ten is the daily action of practicing Steps 3 – 9 that are so vital in my continuing quest for emotional sobriety (Steps 11 & 12). I need Step Ten because not every one of my character defects is removed through Step Seven: no matter how willing I am to let go of them immediately (Step Six).

My character defects pop-up again because some person, place or thing (some event – think Column I & II, Step Four inventory), triggers some disagreeable or uncomfortable emotion (my "reaction" – Column III, Step Four), which rather than process (complete a Step Four inventory) and discard (take Steps Five - Nine), I opt to relive the memory again and again; I brood over it and nurse it; and lo and behold up pops a new resentment, fear or harmful behavior. Thus, I opt to "wet, lather, rinse and repeat."

I get caught in this repetitious cycle because instead of processing and discarding the experience, I take the story that I manufactured about the event and how it affects me as the truth. Unfortunately, It is a story that is essentially incomplete and therefore not entirely true because it is missing the exact nature of my behavior.

By harboring, massaging, and feeding my story (here comes the old "brainstorm," which is another way of saying that my "insane thinking" kicks into high gear), the offense grows, my indignation rises, and I boil-over with contempt or loathing - not to mention, a good old case of self-righteousness to boot!! And what do I get from my brainstorming? A nice new shot of being once again "restless, irritable and discontented." This can be fatal for me, because it is the quickest route back to a drink for this alcoholic.

Unless I find some way to release myself from the bondage of this self-absorption, this nursing of my emotional wounds, I will keep reliving the feeling and keep retelling the story, until I am convinced that the story is the truth and I am justified in my feelings (or I as I like to call it, I get a case of the "Drama Drunks").

What I need is an immediate "processing" system to free me from this self-imposed bondage. I need Step Ten! When the event occurs, that makes me agitated or doubtful. I ask God for "the right thought or action," reminding myself that I am "no longer running the show (Step 3)." Inventorying the situation (Step 4), I talk with someone immediately to test the validity of my story (Step 5).

When my ill feelings crop up, I must become willing to "ask God at once to remove them" (Steps 6 – "be willing" & Step 7 - "ask"). Then I make amends quickly (Steps 8 & 9) whenever appropriate, so that I can step back into emotional sobriety (Steps 11 & 12). End of "Wet, lather, rinse, repeat."

# TRADITION TEN: Alcoholics Anonymous has opinion on outside issues; hence the A.A. name ought never be drawn into public controversy.

Opinions are like, well, belly buttons. Everybody has one. In fact, unlike belly buttons, most of us have a few opinions. I'm no different. I have opinions on politics, religion, world affairs, the Vikings and original recipe versus extra crispy. But as an A.A. member, Tradition Ten suggests that there should be limits to my opinions, or at least to their expression. There are times and places where it may be best for me to keep my opinions to myself. The spiritual principle of the Tradition seems to me to be based on the idea that my opinions can be harmful, to others or to me.

For one thing, no matter how sure I feel about something, I may still be dead wrong. There may be facts and information I don't know, but that doesn't always prevent me from "spouting off". Or, I may be unaware or simply unmindful of the impact my words on a topic may have, either at the time I say them or later, if they are repeated. In short, my actions may have consequences beyond any that I anticipate or desire.

The wisdom and experience of the A.A. Fellowship on this, as it is expressed in this Tradition, protects Alcoholics Anonymous from itself. Outside of the program of recovery itself, A.A. has no opinions. For recovery from alcoholism, Alcoholics Anonymous has a program, proven and time-tested. For all other matters, A.A., as a whole, offers no advice, suggestions, hints, innuendos or, heaven forbid, opinions. This idea too is time-tested, and has preserved our Fellowship through many controversies that have swirled about in the field of alcoholism and in the world at large over the last 70 some years.

In my life outside the meeting rooms of Alcoholics Anonymous, I am free to express my beliefs, so long as I don't suggest that the Fellowship shares them. But the wisdom of restraint, as exemplified in Tradition Ten, can provide me with some helpful guidance and caution when I do. This principle from Tradition Ten can serve me in my practice of Steps Six and Seven, especially at those times when my passions or pride cloud the God-consciousness I seek.

CONCEPT TEN: Every service responsibility should be matched by an equal service authority—the scope of such authority to be always well defined whether by tradition, by resolution, by specific job description or by appropriate charter and bylaws.

Our service structure cannot function effectively and harmoniously unless, at every level, each operational responsibility is matched by a corresponding authority to discharge it. This requires that authority must be *delegated* at every level - and that the responsibility and authority of every entity are well defined and clearly understood.

As we have seen (Concept I) "final responsibility and ultimate authority" reside with the A.A. groups, and they *delegate* this authority to the Conference (Concept II). The Conference, in turn, *delegates* to the General Service Board the authority to manage A.A.'s affairs (Concept III) in its behalf. The board is in authority over its subsidiary operating conditions - A.A. World Services, Inc. and The A.A. Grapevine, Inc. - but it *delegates* to the directors of those corporations the authority necessary to run these service entities. The directors are in authority over the executives of the corporations, but *delegate* to these officers the authority needed to carry out their administrative responsibilities. And finally, the executives *delegate* to the G.S.O. and Grapevine staff members and other employees the *authority* necessary to carry out their important service jobs.

... "To sum up: Let us always be sure that there is an abundance of final or ultimate authority to correct or to reorganize; but let us be equally sure that all of our trusted servants have a clearly defined and adequate authority to do their daily work and to discharge their clear responsibilities."
