Step Five: Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.

Step Five – "What an order! I can't go through with it." Yet there I was sitting with my sponsor about to share with him every nook and cranny of my life's deepest and darkest secrets. Did I want to do this? No of course not! But I did not want to go on the way I was living in the relentless grip of alcoholism. Plus, my sponsor had that something I wanted - he was, "happy, joyous and free."

So we invited the God of my understanding into our conversation and hit the ground running. We started with my sex conduct, since that was an area of my life where I had no sense of proportion or propriety. I had no idea how to share in a healthy, intimate partnership as an honest and unselfish participant. After we finished, we discussed my ideal. My sponsor shared how his ideal had changed and developed as he continued his sober journey. That helped me see that this "New Way of Life" was a process of adoption and growth – it was a relief to know that there was hope for me yet!

Next we reviewed my resentments. As I shared, a pattern emerged which my sponsor helped me to see and to understand. I learned that my infinite wants and needs kept crashing onto the shores of my selfish, self-centered, feardriven expectations. I chronically assumed that others ought to live up to my expectations, rather than allow them to be themselves. I often entered into their lives driven to manipulate our relationship to suit me. This inventory showed me that "I want, I need" is not exactly a healthy prescription for one's relationships or one's way through life!

Fears were next. My sponsor asked if I wanted to be driven by my fears, or would I like to "get in the driver's seat and learn how to be responsible for my actions?" It was simple, he said, "start with the principles of being 'honest, open-minded, and willing' and you'll soon see that instead of being driven by your fears, you'll be motivated by some principles that you can apply in any situation." More relief.

Last, we looked over my harm done to others. What a petty thief I was - I stole - and not just things. I stole people's serenity ("do it for me now!") and their good names (gossip). Inventory completed. It was quite evident that my old ideas of how to live and how to be a participant in the lives of others were deeply flawed.

So what to do? My sponsor suggested I follow the instructions on page 75 of the Big Book. I took some quiet time to review all I had shared. Then I said a prayer of gratitude that I knew myself in a new light. Finally, I reviewed my work on the first Five Steps. Was I ready to let go of my failed old ideals of "successful living, and embrace a new 'Design for Living?'" You bet I was! On to Step Six!

Tradition Five: Each group has but one primary purpose-to carry its message to the alcoholic who still suffers.

"Welcome" is a word not frequently heard by alcoholics, at least until they walk into an A.A. meeting. Once there, the sense of relief can be immediate. "Beaten into complete defeat by alcohol," writes Bill W. in a June Grapevine article, "confronted by the living proof of the release, and surrounded by those who can speak from the heart, we have finally surrendered. And then, paradoxically, we have found ourselves in a new dimension, the real world of spirit and of faith."

Walking into an A.A. meeting often takes courage - and desperation. But our kinship of common suffering and the identification between one alcoholic and another provides the framework of mutual need that is the centerpiece of our communication.

In A.A., there are all kinds of groups. Some....can be as informal as a gathering in the back seat of a car on a rainy afternoon, listening to a speaker tape. Others, more formal, may have a greeter welcoming anxious newcomers or a hospital and intuitions committee extending the hand of A.A. into the community.

Whatever the make-up of the group, one fact remains: "Each group has but one primary purpose - to carry its message to the alcohol who still suffers." So says Tradition Five.

Tradition Three: The only requirement for A.A. membership is a desire to stop drinking.

Stopping drinking and learning to live a spiritual life is hard. We all have struggled in our using and in our sobriety. St Paul Intergroup volunteers answer the phones 24/7, make Twelve Step calls, serve as temporary sponsors, speak at area meetings, schools and facilities, staff the office, etc. When someone needs help there is always someone there. I always wanted to fit in. Once I came to AA I finally belonged somewhere. No one judged me. I was not excluded but was included into a community that saved my life. And for that I am grateful.

Notes From your Central Office...

This month we'd like to send a "shout out" to our Night Owl volunteers!

One of the principal reasons St. Paul Intergroup was formed over 50 years ago was to have a phone number, listed as Alcoholics Anonymous St. Paul in the phone book, so that alcoholics looking for help could find us. For many years, much of the time outside our office hours, the line was answered by a professional answering service. This meant that a new person's first call to A.A. might not be answered by a recovering alcoholic.

Several years ago, some friends of St Paul Intergroup decided that just couldn't go on. Led by Julie B. and Patti M., a Night Owl committee took on the task of getting local A.A. members and groups to commit to answering this line 24/7/365. And they did it!

When this office is closed and someone needing help dials 651-227-5502 their call is answered by a recovering member of Alcoholics Anonymous. Our Night Owl volunteers help people with Twelve Step calls, finding meetings, and by answering questions about A.A. in the St Paul and surrounding area.

Night Owls transfer calls to this line to their own home or cell phone for shifts in the evening, overnight, and early morning. Over 200 A.A. members and groups are on our rolls to perform this service, either with regular monthly shift commitments or as back-ups. And we train new Night Owls each month.

The importance of this is hard to overstate. Countless times, our Night Owls help deliver hope to one who hasn't any. This helps us all "Pass It On".
