# Step Eight: Made a list of all persons we had harmed and became willing to make amends to them all.

As I continue to live each twenty-four hours in the Fellowship of Alcoholics Anonymous and attempt to practice its principals in all my affairs, one Step seems to play an increasingly important role in my life and in my relationships with others. This quiet but potent Step is Step Eight.

Many people, myself included, tend to lump Steps Eight and Nine together. By doing this, I never really achieved even a glimmer of the humility and love that Step Eight has to offer. Being a person of impatient actions, I was off and running on Step Nine with a simple list of names tightly grasped in my sweaty hand and a bad case of false humility to go along with it. Needless to say, I came home each evening with a battered sense of justice and my tail tucked underneath me.

As usual, I did not read all the words contained in the Step, and, just as I had done in Step One, I read only the first half before jumping to my next Step. The resulting self-induced pain has, however, taught me much about myself and the principles of this simple program.

Going back to Step Eight, I read the words at last, "...became willing to make amends to them all." As I began to absorb what was being said to me, and as I reviewed the first seven Steps leading up to this one, It suddenly became clear what the message was for me and what the hasty mistake of impatient interpretation had cost me in serenity. The word "identify" held the key to my success with this Step. To become willing means to become willing to identify myself in others. I had been using Step Eight not as preparation for Step Nine, which is the carrying out of that willingness, but as a hiding place for my own real fear of my true shortcomings. The purpose of Step Eight for me is not to hide but to identify. In order not to identify, I either condemned or forgave as if I were some kind of standard for comparison. In this Step I receive the humility to "Identify," to see myself in others and to share their burdens and difficulties by sharing myself. In this Step I truly join the human race. My identification becomes my freedom – freedom from fear and anger. When I can identify my own shortcomings in another, the battleground between us is removed.

I cannot make amends when I am still condemning or forgiving myself or the one I am making amends to, because of the judgment this implies. I have always found condemnation to be a lonely road and have always found forgiveness to be a confusing and impossible task. When I forgive someone I guess what I really mean to say is that I admit I judge others. Forgiving and condemning are God's business, not mine. Only he has the mercy to judge and accept at the same time. My job is to achieve enough humility to see myself in others and to accept both myself and others, by identifying. The willingness to make amends will grow from this act of love. When I become "willing to make amends to them all" I am saying to them, "your pain is my pain; when I hurt you, I hurt myself; I will try not to hurt you anymore."

When I have achieved this kind of willingness to identify, my Higher Power has always set up my amends and allowed both of us to grow from the love involved in such an act.

# Tradition Eight: Alcoholics Anonymous should remain forever non-professional, but our service centers may employee special workers.

On June 15<sup>th</sup> your Intergroup office celebrated 56 years of incorporation and service to the alcoholic in need, and the A.A. groups and members active in St. Paul and its Suburban Areas. At the time of incorporation in 1966, St. Paul Area Intergroup served 13 groups with 35 regularly scheduled meetings. Today we provide support and services to 280 groups holding about 650 active meetings.

Our mission remains the same from the day of our incorporation: helping alcoholics in need find the fellowship they seek; giving information on Alcoholics Anonymous to other interested parties; serving as a distribution center for A.A. and Grapevine literature; supporting the established principles and traditions of Alcoholics Anonymous; and providing service opportunities to the St. Paul and Suburban Area A.A. Groups and Members.

To assist in carrying-out your Intergroup's mission, the office currently employs three dedicated paid staff – two part-time service workers and a manager. These folks are your Intergroup's Tradition Eight Special Workers. "Making good and effective Twelve Step work possible," is the aim of your staff, and we are grateful to be of service to you and those who reach us seeking help.

#### From Your Intergroup Board...

Recently an Ad Hoc Committee comprised of local AA community members was tasked with evaluating the Intergroup Events Calendar, to determine if each event was effectively furthering Intergroup's primary purpose of reaching the still suffering alcoholic. Even before the Committee comes back to the Board with recommendations, I am struck with gratitude at the nature of this endeavor.

First, it is a privilege and a gift to be able (individually and collectively) to "take inventory" and assess the nature of the stock-in-trade. That sort of accurate and humble self-analysis is the sort of right action that so often brings about positive growth. I'm proud to be a part of an organization that isn't wed to doing things one way, simply because that's how it's always been done.

Second, what an extraordinary luxury to be a part of an AA community that is so well-developed and amplymanned that Intergroup perhaps need not be the sole vehicle for carrying the message on every occasion. The strong Groups and Districts serving this community make it possible for Intergroup to focus on what it does well, reaching the newcomer in the most effective manner possible.

#### Notes From your Central Office...

Your St. Paul Intergroup office serves as a source of information and assistance for many in this community. Of course, we are reached by those who wish to stop drinking, and for them we offer immediate assistance through our Twelve Steppers. We also handle many inquiries about area meetings and AA workshops and events.

The Intergroup office often also gets contacted by members of the professional communities seeking information and assistance. These inquiries may come from people in the health care, human services and the legal fields. Most often, they involve questions about how our Fellowship and program of recovery can reach the clients they serve.

For example, we were recently asked to help get an in-house AA meeting started in a local women's shelter. We contacted a women's AA group that met near the facility and asked them whether they might wish to reach out to this shelter as a service opportunity.

We have also tried to be of service to organizations assisting immigrant communities. We've recently supplied information and AA literature for the local Hmong and Lithuanian communities.

A St. Paul hospital has contacted us about persons admitted to their emergency room who could be served by speaking to a member of Alcoholics Anonymous. In this instance, office staff and the Night Owl committee formed a group of AA members who could be called upon to visit emergency room patients at this facility.

The location of our office also brings us contact with the legal field. We are located, in the Spruce Tree Centre, directly across the hall from one of the area's largest probation offices. This "traffic" in our hallway brings us many visitors who are in the building to visit their agents. In addition, probation officers often bring their clients across the hall for information about our program of recovery and meetings.

We are grateful for each and every opportunity to carry the AA message of Recovery to all who contact us, be they the alcoholic in need, an AA member or group, or those interested in learning more about our The AA Way of Life.
