Step Two: Came to believe that a Power greater than ourselves could restore us to sanity.

I came to Alcoholics Anonymous because I had nowhere else to turn. I was 46 years-old, and my beloved alcohol had stopped working for me. Not to mention that my family was fed-up with me; my friends had tired of my drunken antics; and my landlords were ready to throw me out of my apartment.

I came to an A.A. meeting in despair and with little hope of a solution to my predicaments. Listening to the voices at the meeting I came to believe there was something they had that I wanted.

After the meeting I asked a man to sponsor me. We sat down to talk. He told me about this drinking career and the twisted way his thinking kept leading him back to the first drink until he accept the A.A. program outlined in the Big Book. He told me something that upended all my old ideas about A.A. He said, "A.A. didn't get me sober and A.A. doesn't keep me sober." I was floored. Then he said, "What A.A. <u>did</u> was help me to find and tap into a Power greater than myself. It is that Power which brought me into Recovery and keeps me sober today, as long as I continue to live by the Principles I learned through living in the Steps."

At that moment I too, "Came to believe that a Power greater than ourselves could restore us to sanity." That night, before I went to sleep, I commitment myself to the A.A. way of life and the Power, I call "God." I got down on my knees and quietly recited the Third Step prayer, with all my heart, as my roommate snored in his bed across from me. The next day I started writing inventory, and so began the journey of embracing the A.A. way of life in all its wondrous manifestations. It's been many years since my last drink, and I am ever grateful to A.A.

Tradition Two: For our group purpose there is but one ultimate authority a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

Where does A.A. get its direction? ... These practical folk then read Tradition Two, and learn that the sole authority in A.A. is a loving God as He may express Himself in the group conscience ... The elder statesman is the one who sees the wisdom of the group's decision, who holds no resentment over his reduced status, who judgement, fortified by considerable experience, is sound, and who is willing to sit quietly on the sidelines, patiently awaiting developments. - TWELVE STEPS AND TWELVE TRADITIONS, pp. 132, 135

Into the fabric of recovery from alcoholism are woven the Twelve Steps and the Twelve Traditions. As my Recovery progressed, I realized that the new mantle was tailor-made for me. The elders of the group gently offered suggestions when change seemed impossible. Everyone's shared experiences became the substance for treasured friendships. I know that the Fellowship is ready and equipped to aid each suffering alcoholic at all crossroads in life. In a world beset by many problems, I find this assurance a unique stability. I cherish the gift of sobriety. I offer God my gratitude for the strength I receive in a Fellowship that truly exists for the good of all members.

Concept Two: The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole society in its world affairs.

When I think about Concept Two and how I might apply it in my life, it boils down to 4 things; delegation of responsibility, trust in another, voice to discuss and a sense of collaboration. These are great things to consider in any relationship, but pretty much essential in a marriage.

Between my marriage partner and me, we delegate to one another various responsibilities. Whether the responsibility is to maintain the car, maintain the home, maintain the yard, or any of the other areas in our environment that are in need of consistent attention. Once the responsibility is delegated – that person has a "right of decision" how to carry that out.

Since our relationship is built on trust in one another, we have confidence that the person to whom a responsibility is delegated will consider the group conscience, or collaborative direction of our lives, when making their decisions. Those decisions should always be made to further our collaboratively developed goal for our lives together.

Certainly as time goes on each of us, facing a decision related to our delegated responsibility, will need or want to get a better sense of the best approach in that specific instance. So I expect that there will be an opportunity for me to give voice to my understanding of the situation and any potential solutions I see to it.

By using the principles in Concept Two, our relationship takes on new meaning, builds trust and results in better decision-making as well as providing us with an opportunity to share a vision for our future together.

It's an honor to be among a group of people who care so deeply about St. Paul Intergroup.

I wish newcomers to A.A. well—always, not just in the New Year. I hope the January crowds stick around throughout 2017 and beyond.
